

MAGENTO EXTENSION LICENSE AGREEMENT, VERSION 1.0

Order Management Services

This License Agreement (the "Agreement") establishes the terms on which Radial, Inc. ("Radial") grants to you, the licensee ("You" or "Your") a license to download and use Radial's a license to Radial's applicable proprietary software and related documentation (the "Software") solely on the condition that You accept all of the terms in this Agreement. By clicking through any applicable acceptance screen, or otherwise accessing, downloading, installing, or using the Software, you are indicating your acceptance of this Agreement, and if you do not agree to the terms of this Agreement, you may not access, download, install, or use the Software.

- 1. TRIAL LICENSE. (a) During a ninety (90) "**Trial Period**" beginning from you download of the Software, subject to Your full and ongoing compliance with all terms and conditions of this Agreement, Radial hereby grants You a limited, revocable, non-exclusive, non-transferable, non-sublicensable license to install and use the Software in your internal environment solely for the purpose of testing of the Software and its integration of Your ecommerce webstore with Radial's Order Management ("**ROM**") services. The Trial Period may be extended upon Radial's agreement.
- (b) You acknowledge that you must contact Radial and obtain a test API Key from Radial to test Your integration with ROM services and that this Software is strictly for testing purpose until You enter into an agreement for the purchase of ROM services from Radial (a "Services Agreement"). Your license to the Software for production use will be granted pursuant to the Services Agreement and subject to additional terms and conditions.
- 2. RESTRICTIONS. (a) You will not, and will not allow any third party to: (i) modify, alter, tamper with, repair, or otherwise create derivative works of the Software; (ii) sell, sublicense, rent, lease, distribute, market, or commercialize the Software; (iii) decompile, disassemble, translate, reverse engineer or otherwise attempt to derive source code from any portion of the Software, except and solely to the extent that the foregoing restriction is impermissible pursuant to applicable law or third party license; (iv) remove, alter or obscure any proprietary notices of Radial, its licensors or suppliers included in the Software; or (v) publicly disseminate performance information about or analysis of the Software, including benchmarking test results. You may not, and will not allow any third party to, use the Software in connection with an application or service provided by an entity other than Radial. No third party may access, view or use the Software under this Agreement.
- (b) During the Trial Period, You will not utilize the Software to process or provide Radial with any data related to any real persons. All such test data, including test credit card data, shall be fictional test data. As a result, You agree that Radial shall have no liability whatsoever for its processing of any data provided by or on Your behalf.
- 3. NO FEES; OPERATING EXPENSES. Subject to the terms of this Agreement, You and Radial agree that no license fees or other fees shall be payable under this Agreement in exchange for the rights granted and/or the use of the Software or other materials provided under this Agreement.
- 4. OWNERSHIP. The Software, and all worldwide Intellectual Property Rights to the Software are the exclusive property of Radial and its licensors. Radial and its licensors reserve all rights in and to the Software not expressly granted to You in this Agreement, and no other licenses or rights are granted by implication, estoppel or



otherwise. "Intellectual Property Rights" means (a) any and all now known or hereafter known tangible and intangible: (i) rights associated with works of authorship throughout the world, including but not limited to copyrights, moral rights, and mask-works; (ii) trademark, trade dress and trade name rights and similar rights; (iii) trade secret rights; (iv) patents, designs, algorithms and other industrial property rights; and (v) other intellectual and industrial property rights of every kind and nature, however designated, whether arising by operation of law, contract, license, or otherwise; and (b) all registrations, initial applications, renewals, extensions, continuations, divisions or reissues hereof or hereafter in force regarding any of the foregoing and under the laws of any jurisdiction.

- 5. FEEDBACK. If you choose to provide Radial with suggestions, enhancement requests, recommendations or other feedback provided by You relating to the Software or the Radial Services ("Feedback"), You acknowledge and agrees that all Feedback will be the sole and exclusive property of Radial, and You hereby irrevocably transfer and assign to Radial all of Your right, title, and interest in and to the Feedback, including all Intellectual Property Rights therein. At Radial's request and expense, You will execute documents and take such further acts as Radial may reasonably request to assist Radial to acquire, perfect and maintain its Intellectual Property Rights and other legal protections for the Feedback.
- 6. TERM. This Agreement shall commence when you download the Software and shall continue in force and effect until the expiration of the Trial Period. Either party may terminate this Agreement, with or without cause, immediately upon written notice to the other party. This Agreement will terminate immediately and without notice if you breach any term or condition of this Agreement. Upon the expiration or any termination of this Agreement, the license and all rights granted to You under this Agreement will immediately terminate, and You shall promptly purge and destroy all copies of the Software in Your possession. Provisions intended by their nature to survive termination of this Agreement survive termination.
- 7. WARRANTY DISCLAIMER. THE SOFTWARE IS PROVIDED TO YOU "AS IS" AND WITH NO REPRESENTATION OR WARRANTY OF ANY KIND. EXCEPT TO THE EXTENT PROHIBITED BY LAW, RADIAL AND LICENSORS EXPRESSLY DISCLAIM ANY AND ALL WARRANTIES AND REPRESENTATIONS OF ANY KIND WITH REGARD TO THE SOFTWARE OR THIS AGREEMENT, INCLUDING ANY WARRANTY OF NON- INFRINGEMENT, TITLE, FITNESS FOR A PARTICULAR PURPOSE, FUNCTIONALITY OR MERCHANTABILITY, WHETHER EXPRESS, IMPLIED OR STATUTORY.
- 8. LIMITATION OF REMEDIES. IN NO EVENT SHALL RADIAL BE LIABLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL, CONSEQUENTIAL OR PUNITIVE DAMAGES IN CONNECTION WITH THIS AGREEMENT, REGARDLESS OF THE NATURE OF THE CLAIM OR THEORY OF LIABILITY, INCLUDING, WITHOUT LIMITATION, LOST PROFITS, COSTS OF DELAY, ANY FAILURE OF DELIVERY, BUSINESS INTERRUPTION, COSTS OF LOST OR DAMAGED DATA OR DOCUMENTATION OR LIABILITIES TO THIRD PARTIES ARISING FROM ANY SOURCE, REGARDLESS OF WHETHER THE RADIAL HAS BEEN NOTIFIED OF THE POSSIBILITY OF SUCH DAMAGES. WITHOUT LIMITING THE FOREGOING, RADIAL'S CUMULATIVE LIABILITY FOR ALL CLAIMS ARISING FROM OR RELATING TO THIS AGREEMENT, INCLUDING, WITHOUT LIMITATION, ANY CAUSE OF ACTION SOUNDING IN CONTRACT, TORT, OR STRICT LIABILITY, SHALL NOT EXCEED ONE HUNDRED DOLLARS (U.S. \$100.00). THE FOREGOING LIMITATIONS WILL APPLY NOTWITHSTANDING THE FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY PROVIDED HEREIN.
- 9. ESSENTIAL BASIS OF AGREEMENT. The Parties acknowledge and agree that the disclaimers, exclusions and limitations of liability set forth in Sections 7 and 8 form an essential basis of this Agreement, and that, absent any of such disclaimers, exclusions or limitations of liability, the terms of this Agreement, including, without limitation, the economic terms, would be substantially different.



10. GENERAL. You agree that Radial may use any contact information regarding You or Your personnel provided in connection with the downloading or use of the Software to contact You or Your Personnel for the purposes of marketing and selling Radial's services to You. This Agreement shall be governed by and interpreted in accordance with the laws of the Commonwealth of Pennsylvania, without regard to conflicts of law principles thereof or to the United Nations Convention on the International Sale of Goods. For purposes of all claims brought under this agreement, each of the parties hereby irrevocably submits to the exclusive jurisdiction of the state and federal courts located within Philadelphia County, Pennsylvania. Radial may assign this Agreement, in whole or in part, at any time with or without notice to You. You may not assign this Agreement, or any part of it, to any other party. Any attempt by You to do so is null and void. If any provision of this Agreement is held to be unenforceable, that provision will be enforced to the extent permissible by law and the remaining provisions will remain in full force and effect. No waiver under this Agreement shall be valid or binding unless set forth in writing and duly executed by the party against whom enforcement of such waiver is sought. Any such waiver shall constitute a waiver only with respect to the specific matter described therein and shall in no way impair the rights of the party granting such waiver in any other respect or at any other time. Any delay or forbearance by either party in exercising any right hereunder shall not be deemed a waiver of that right. This Agreement is the complete and exclusive statement of the agreement between us and supersedes any proposal or prior agreement, oral or written, and any other communications between You and Radial in relation to the subject matter of this Agreement.
